

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.moneyhungry.me and MoneyHungry, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MoneyHungry, LLC include www.moneyhungry.me. The MoneyHungry, LLC website is a Installment Loans site. By using the MoneyHungry, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, MoneyHungry, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Drivers License, Social Security Numbers, Date of Birth

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Automatically Collected Information
